This Terms of Usage Agreement is made effective as of the time of purchase of any Art *NXT* Level services (i.e., membership) between the Client (i.e., active member) and Art *NXT* Level, located at 33 Contemporary Gallery, 1029 W. 35th Street, Chicago, IL 60609.

- Description of Products.** Art *NXT* Level Strategic Group is an online membership community for the working artist (i.e., client). This site offers clients training, coaching, advice and resources to help develop their art career.
- Payment.** We accept major credit cards. We use Stripe to process credit card payments.
- Refund Policy & Guarantee:** There are no refunds. Client may cancel at anytime by clicking Cancel Membership in the Membership Account Tab located inside the membership site prior to the next billing due date to avoid future charges. However, once charged, no refunds will be provided. Cancellations will be effective on the last day of the client's billing cycle. If Client decides to re-enroll in Art *NXT* Level after canceling the membership, Client is subject to the new membership price as posted on the website. Client will no longer be entitled to the initial or previous price. Client is 100% responsible for individual results as it is the client's responsibility to follow through and implement what is learned in the trainings and coaching provided.

Each party shall bear its own costs and expenses and an equal share of the arbitrators' and administrative fees of arbitration. Except as may be required by law, neither a party to this Agreement, nor any party or participant in an arbitration, nor any arbitrator may disclose the existence, content, or results of any arbitration hereunder without the prior written consent of the parties to this Agreement.
